2012 NONRESIDENT COMBINATION LICENSE AND DEER AND ELK PERMIT APPLICATION PACKET

NEW DEADLINE

The FWP Commission recently changed the deadline for Deer and Elk permits from June 1st to **March 15th**. In the past Nonresidents had to apply for a license by March 15th and then apply by June 1st for a deer or elk permit. Now you'll be able to apply for your license and deer and elk permits on the same application and have drawing results by the end of April, providing three additional months to make plans, scout, talk to landowners and get in shape.

The deadline to apply for Moose, Sheep, Goat, and Bison licenses remains May 1.

The deadline for antlerless Elk B and Deer B—Antelope and Antelope B—licenses remains June 1.

THIS NEW APPLICATION PACKAGE IS FOR NONRESIDENT COMBINATION LICENSES AND ELK AND DEER PERMITS. APPLY BY MARCH 15 USING THE FOLLOWING STEPS:

1. Choose the Nonresident Combination License for which you wish to apply:

Big Game Combination (\$944) General Elk and Deer, Upland Game Bird, Fishing, Conservation license and Hunting Access Enhancement Fee (HAEF). A total of 17,000 are available.

Elk Combination (\$794) General Elk, Upland Game Bird, Fishing, Conservation license and HAEF. The available license are included in the 17,000 noted above.

Deer Combination (\$561) General Deer, Upland Game Bird, Fishing, Conservation license and HAEF. A total of 4,600 are available.

Landowner Sponsored Deer Combination (\$561) Landowner Deer (valid only on LO's property), Upland Game Bird, Fishing, Conservation license and HAEF. A total of 2,000 are available.

2. Determine if you need a Deer or Elk permit in your hunting area. A permit and a general license are required to hunt Bull Elk and Buck Mule Deer in certain hunting districts.

- Your permit must be used with your General Elk or Deer hunting license. A permit is not a second license and does not allow the holder to kill an additional animal. Rather, it offers a special opportunity to hunt for a species in a particular hunting district allowing the hunter to harvest a buck mule deer or bull elk.
- Review the maps for Elk and Deer. If the hunting district where you wish to hunt indicates a permit is required, you must apply by March 15. If the map indicates that no permit is required, your General Elk or Deer license is all you need to hunt there during the 2012 general hunting season.

3. If you apply for a Big Game or Elk Combination License—and an elk permit—you must choose from the following options if you are not awarded an elk permit via the drawing

- Keep your Big Game or Elk Combination license, or

- Request an 80 percent refund, or
- Turn in the General Elk license portion of your Big Game Combination License and retain the deer, fishing, and upland game bird licenses and receive a \$358 refund.

4. Pick the correct elk and deer permit code and know the hunting district

Some hunting districts have more than one option for a permit—for instance, HD 631 offers one for archery-only and one for general season only, while HD 380 offers one for archery and the general season. Some permits—like those offered for deer in HDs 213 and HD 298—also are valid in more than one hunting district. **NOTE: Hunting districts that have a quota of “pending” will not be finalized until the FWP Commission meets on Feb. 16; do not apply for these hunting districts until you have verified the commission’s action.**

5. Are you applying as a party?

NOTE: In Montana, a “party” simply means that a group of hunters are applying together for the chance to obtain hunting licenses or permits. **It is strictly illegal to transfer any hunting license. Each individual in the application “party” must harvest his or her own game.**

For paper applications: Make sure: (1) all party members are listed; (2) all party members apply for the same hunting districts, in the same order and include the same preference/bonus-point participation; (3) all party applications must be submitted in the same envelope; (4) if one party member makes an error, that application will be eliminated but the remaining will be processed.

For online applications: The party establisher must list all party members and provide the number to all members so each member can apply online for that party.

6. Complete your application

For paper applications:

- Fill in date of birth, ALS #
- Complete all mandatory information
- Original signature
- Select the license type
- For permits, fill in the hunting districts (All 5 numbers)
- Double-check your math
- Postmark no later than March 15th

For online applications:

- Go to fwp.mt.gov, and select “Buy a license”

Additional Information for Nonresident Hunters

■ Hunter Education Requirements

If you were born after January 1, 1985, you are required to show proof of completing a Montana hunter safety and education course; or an approved hunter safety course from any other state or province prior to applying for or purchasing any hunting license. Duplicate certificates of completion for the Montana hunter education and bowhunter education courses may be obtained from FWP's website at fwp.mt.gov.

■ Bowhunter Education Requirements

To purchase a Montana bow and arrow license, a hunter must provide a certificate of completing the National Bowhunter Education Foundation course; or provide any prior year's bowhunting/ archery stamp, tag, permit, or license from any state or province; or pay \$5 and sign an affidavit stating to the FWP Enforcement Division that you previously held such a license.

■ Bow and Arrow License

Must be purchased to hunt during: (1) any Archery Only Season; or (2) to archery hunt in an Arch-Equip only Area or hunting district.

■ Youth Hunter Requirements

Youths who have completed Hunter Education, and who will turn 12 years of age before Jan. 16, 2013, may purchase or apply for licenses and hunt after Aug. 15, 2012.

■ Landowner Preference

To claim landowner preference for a deer permit, a landowner must own or be contracting for purchase at least 160 acres of contiguous land within the applied for hunting district. For a landowner preference elk permit, the landowner must own or be contracting for purchase at least 640 acres of contiguous land within the applied for hunting district. To obtain the required 2012 Landowner Preference application form, call 406-444-2950.

Tips for a successful application

■ Permit drawing choices

- ▶ Your first choice is required, second and third choices are optional. If you have only one choice do not repeat the choice as a second and third option.
- ▶ Your second or third choices will only be considered if there is a quota remaining or if the quota is unlimited and allows second or third choice applicants.
- ▶ Your best chance to use your second or third choice is if you choose a hunting district where drawing odds are 100 percent or unlimited and allow second or third choices.

■ Check your odds of drawing a permit

- ▶ The general drawing statistics for elk and deer permits are located below the deer and elk hunting district maps included in this application packet.

■ Preference Points and Bonus Points

Preference Points increase the likelihood of obtaining a combination license.

- ▶ Preference points essentially move you ahead in line.
- ▶ For instance, a person with three preference points is in front of the person with two, and so on.
- ▶ Beginning this year, 75 percent of all combination licenses awarded via the drawing will be issued to hunters with preference points.
- ▶ All preference points accumulate over time until you obtain a combination license.
- ▶ If you wish to participate in the Preference Point program for your combination license, make sure to check "YES."

on the Preference Point question and include the \$50 Preference Point fee.

- ▶ Preference points are lost if they are not used for two consecutive years.

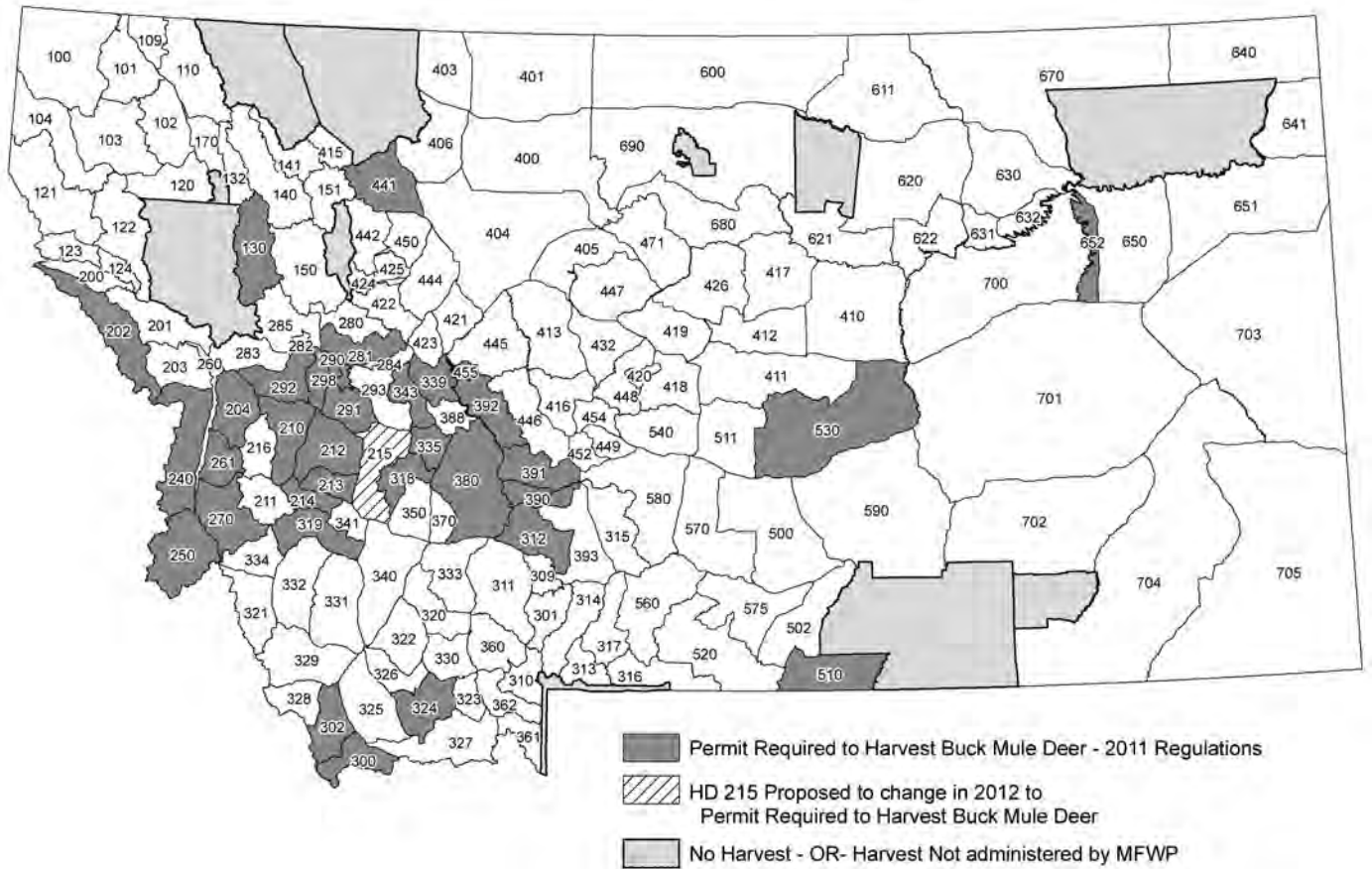
Bonus Points can increase your chances to draw a buck mule deer or bull elk permit.

- ▶ Bonus points essentially offer you additional drawing chances.
- ▶ For instance, a person with two bonus points will have two chances to have his/her application drawn.
- ▶ In addition, beginning this year, existing bonus points will be mathematically "squared" prior to the drawing.
- ▶ That means if you already have three "base" bonus points those will be "squared" and you'll then have nine bonus points going into the 2012 drawing.
- ▶ If you're unsuccessful, you'll be awarded an additional base bonus point for next year's drawing.
- ▶ If you wish to participate in the Bonus Point program for Deer/Elk permits, make sure to check "YES" on the Bonus Point questions and include the \$20 Bonus Point fee.
- ▶ All "base" bonus points accumulate over time until you obtain a permit or you fail to participate in the bonus point system.
- ▶ Bonus points are lost if they are not used for two consecutive years.

Deer Permits. Apply by March 15.

- Hunters who receive a deer permit must use it with a current general deer license. A deer permit does not allow you to take a second deer.
- Hunters who receive a deer permit valid for taking an antlered buck mule deer (with their general deer license) are restricted to taking an antlered buck mule deer only in the district or portion of district specified on the permit. They may not hunt antlered buck mule deer anywhere else in Montana even if the General Season or Archery Only Season is open to mule deer buck hunting with a general deer license. This applies to all deer permit areas, whether limited or unlimited, for antlered buck mule deer.
- Permits and licenses are labeled with a three-digit number followed by a dash and then a two-digit number (such as "213-40"). The first three digits identify the hunting district, and the last two digits are FWP codes for additional opportunities related to that license or permit.
- Permits are valid for antlered buck mule deer unless otherwise specified.

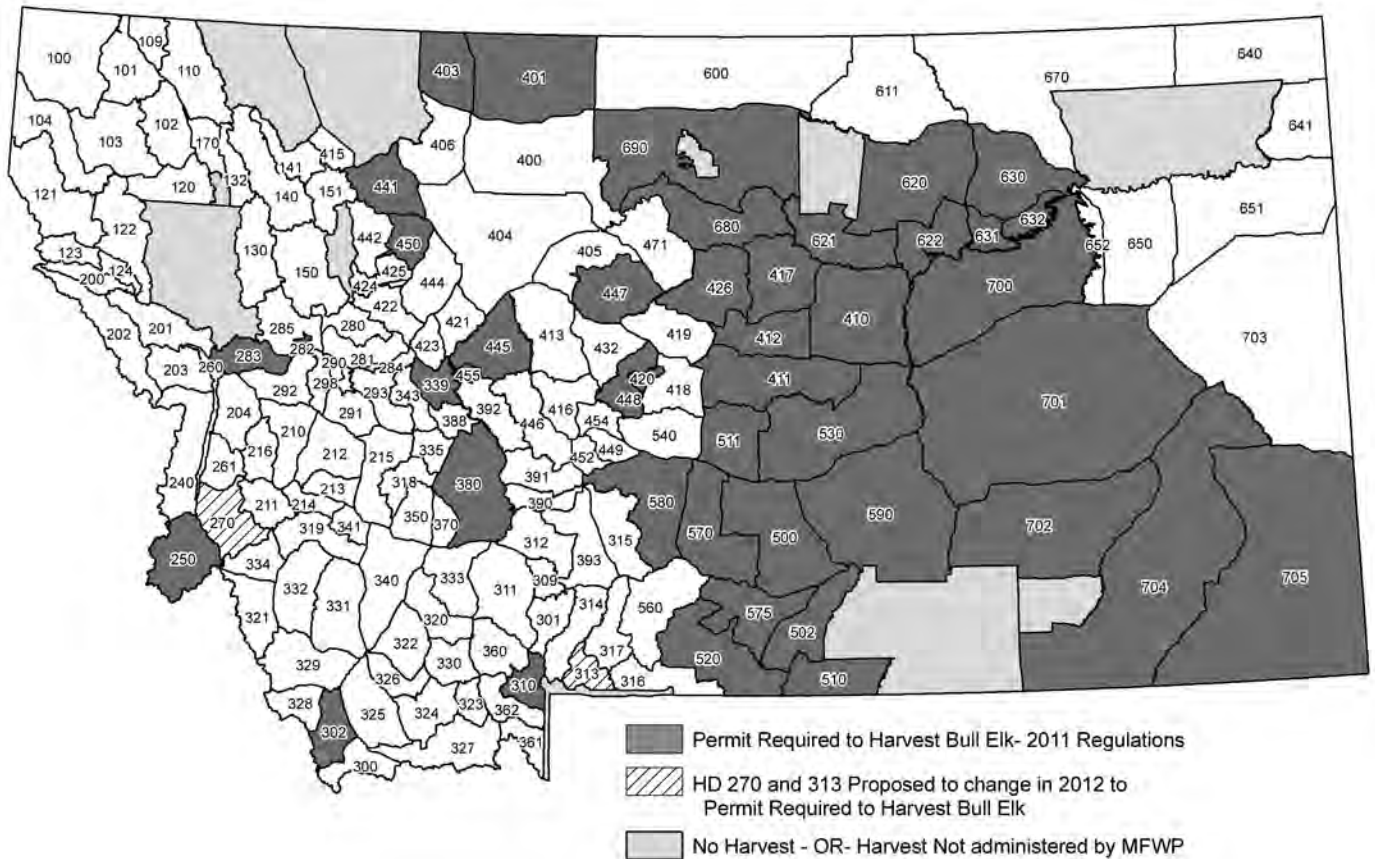

Elk Permits. Apply by March 15.

- Hunters who receive an elk permit must use it with a current general elk license. An elk permit does not allow you to take a second elk.
- Elk permits, allotted by drawings, allow you to hunt in a restricted area or time period or to harvest a bull where harvest restrictions exist for hunters who have only a general elk license.
- Permits and licenses are labeled with a three-digit number followed by a dash and then a two-digit number (such as "380-20"). The first three digits identify the hunting district, and the last two digits are FWP codes for additional restrictions related to that license or permit.
- Elk permits are valid for either sex elk unless specified as brow-tined bull elk only.

Additional Nonresident Hunting Licenses for 2012

■ “Come Home to Hunt”

To qualify you must have previously hunted in Montana as a resident or hold a Montana hunter education certificate. This license requires a sponsor who is a Montana resident family member, including direct In-laws, who also holds a 2012 resident hunting license. Applications with detailed qualifying information will be available online at fwp.mt.gov on Jan. 16. These applications must be submitted to FWP’s Headquarters in Helena.

- ▶ **Big Game Combination** (\$944) Includes General Deer and Elk, Upland Game Bird, Fishing, Conservation license and HAEF. A total of 500 are available.
- ▶ **Deer Combination** (\$561) Includes General Deer, Upland Game Bird, Fishing, Conservation license and HAEF. A total of 500 are available.

■ Youth Combination (\$474.50)

Includes General Elk and Deer, Upland Game Bird, Fishing, Conservation license and HAEF. There is no sales limit quota. Youth must be at least 12 and under 18 years of age with a sponsor who is a natural or adoptive parent, grandparent—or adult brother, or sister—who also holds a 2012 resident or nonresident general deer or elk license. The youth must hunt with the licensed sponsor. Applications are available March 1 online at fwp.mt.gov and must be issued through FWP’s Headquarters in Helena.

NOTE: Nonresidents who are applying for a party for elk or deer permits with a youth in the party must have the youth apply for a General combination license with the party and if successful, the Department will refund the difference upon request and issue a youth combination license.

■ “Nonresident, Montana Native Hunting Licenses”

These licenses are available at substantially reduced prices for purchase only from an FWP office beginning March 1. They include: **General Elk** (\$80), **General Deer** (\$64) and **Upland Game Bird** (\$30). To qualify you must:

- Provide a birth certificate verifying your birth in Montana, or documentation that you were born to parents who were residents of Montana; and
- Proof of possessing a previous Montana resident hunting or fishing license, or proof of passage of Montana’s hunter education course; and
- Proof that you are a nonresident relative of a Montana resident who is your natural or adoptive sibling, child or parent.
- Applications with detailed qualifying information will be available online at fwp.mt.gov on March 1.
- To obtain a license, applications must be submitted in person to any FWP office.
